QUOTATION FOR HIRING A/C DIESEL CAR

Sealed quotations are invited from Firms / Individuals for hiring of A/C Diesel Car of Maruti / Toyota or equivalent make on monthly rental basis for one year period from 1st January 2019 onwards for Kannur Regional Office – Marti Swift Dezire / Toyatto (1500 km).


The quotations shall be reached to the Regional Manager, Regional Manager's Office, Govt. Taluk Hospital, Campus, Payyannur, Kannur before 4.00 PM on 24-12-2018 in the following schedule of rates. Interested parties may quote their monthly rate inclusive of all expenses like cost of diesel, salary of driver, maintenance charges, taxes etc., subject to the following terms and conditions.

Terms & Conditions

1. The rate shall be inclusive of Taxes and any other statutory deductions if any.
2. The vehicle should be Kerala registered on or after 01-01-2015 and shall not run more than 40,000 km. Copy of registration certificate shall be enclosed along with the quotation.
3. The vehicle shall be driven by qualified driver less than 50 yrs old with valid driving license and good health and quality vision (copy to be attached).
4. The vehicle shall have valid insurance coverage (copy to be attached).
5. The vehicle shall run throughout Kerala state during day and night hours and also on Sunday and holidays if required.
6. For additional travelling excess to Km limit the contrat is eligible additional Km rate quoted and approved.
7. Payment shall be made through cheque against contractors' monthly bill after deducting statutory deductions before 10th of next calendar month. A log book shall be maintained properly with signature of the concerned officer performing each travel.
8. The vehicle shall be produced for inspection before placing order. The contractor has to execute an agreement in Kerala stamp paper worth Rs. 200/- within 7 days from the date of work order issued.
9. KHRWS reserve the right to reject any or all quotations without assigning any reason thereof.

10. The agreement can be terminated by both parties by giving 2 months notice.
11. Security deposit of Rs. 15,000/- may be deducted from the first three monthly bills equally and shall be forfeited on premature termination of agreement without two month notice.
12. The contractor has to arrange alternate arrangement if the vehicle is out of order and in the absence of alternate arrangement, the Society shall arrange the same and deduct the amount from your bill.
13. Any dispute arising in this regard shall be subject to the Court of Jurisdiction at Thiruvananthapuram.
14. The Contractor shall sign all pages of the quotations as a token of acceptance.
15. Interested parties shall submit separate offers, in envelopes indicating which item is quoted.
